



AGREEMENT OF COLLABORATION

This Agreement is made by and between **Q** University, represented by the rector. Professor Aisulu Dzhanegizova, based on the Charter of the institution, and Shobhit University, represented by the rector, Professor Dr. Shri Kunwar Shekhar Vijendra, based on the Charter of the institution, collectively referred to as "Parties", on the basis of mutual interests and principles of equality, came to the expediency of mutually beneficial collaboration and agreed on the following intentions:

- 1. The parties join efforts to develop and implement educational projects for cooperative educational process in the bachelor and master degree programs, using international relations and experience in the use of efficient technologies accumulated in the implementation of educational activities;
- 2. The parties unite their efforts in the implementation of research and consulting projects on the territory of the Republic of Kazakhstan and India.
- 3. In order to establish and improve the forms of business collaboration, the Parties will cooperate in organizing seminars, symposiums, conferences, business meetings, as well as other mutual events;
- 4. The parties collaborate in joint projects and promote them during the period determined in each particular agreement;
- 5. For each specific project, the Parties will develop and conclude a separate agreement determining the rights and responsibilities of the parties and their financial relationships;
- 6. By necessity, the parties will form temporary working groups to accomplish projects and activities in accordance with the Agreement, involve specialists from both sides to ensure success of planned events, as well as hold consultative activities to discuss coordinated actions aimed at eliminating deterrent factors towards the development of bilateral collaboration;
- 7. In order to ensure operational coordination of interaction, the Parties form a united working group for the entire period of preparation and organization of projects or activities;
- 8. The parties exchange information essential for collaboration and mutual interest, as well as other information:
- 9. The parties provide mutual support in various organizations, as well as assist each other in joining those international organizations of which one of the parties is a member;
- 10. The parties in their relations are guided by goodwill aimed at mutually beneficial collaboration, and will build their relations on the basis of equality and honest partnership;
 - 11. The Agreement may be amended or supplemented by mutual agreement of the parties;
 - 12. Decisions on the issues of the Agreement are made by the parties jointly.

- 13. The Agreement shall come into force upon being signed by both parties and shall be valid for five (5) years. Each Term shall automatically renew for subsequent periods of the same length as the initial Term unless either party gives the other written notice of termination at least thirty (30) days prior to expiration;
- 14. This agreement is made in duplicate, one copy for each party and each copy bearing the same legal effect.
